I/we will reimburse RAA in full if the vehicle is returned/repurchased by RAA, including transportation necessary.

Proceeds checks will be paid only upon receiving a marketable title by RAA and buyer payment in full.

Titles and proceeds checks will be mailed 14 days after auction date or 14 days after a marketable title is produced after the auction date.

I/we have read and understand all auction policies and will abide by them when selling vehicles and agree to indemnify and hold harmless Richmond Auto Auction of Virginia, Inc. from any and all claims made against it or arising from all transactions regarding this consignment and auction sale thereof.

I/we understand that mileage is not guaranteed. All vehicles should be assumed as true miles unknown and/or may exceed mechanical limits.

If a vehicle is consigned to RAA and is removed for any reason, RAA is entitled to the sales commission as outlined in this contract.

By accepting this registration agreement, you award RAA the right to exclusively market and sell the vehicle for 30 days after the conclusion of the sale.

This addendum to the Richmond Auto Auction of Virginia, Inc.'s (RAA) Vehicle Consignment Registration is an acknowledgement that the consignor(s) signing below is aware and understands the following regarding any and all vehicles that the consignor(s) may consign to the RAA staff for subsequent auction sale and that while the RAA will exercise the utmost care for the consignor's vehicles the consignor(s) understands that the following conditions or circumstances may apply to their consigned vehicle(s):

1. The vehicle(s) may not be stored indoors and if stored indoors may need to be moved out of doors from time to time while in RAA possession;
2. Weather conditions will not impede RAA from conducting its scheduled auction nor any necessary preparation and vehicles may be subject to adverse weather conditions beyond the control of the RAA;
3. Potential buyers may wish to inspect the vehicle(s) and may therefore come in contact with them;
4. RAA personnel will be required to drive the vehicle(s) from time to time and drive the vehicle(s) through the auction lanes when offered for auction sale;
5. It may be required that the vehicle(s) is/are towed. As a result any special towing instructions and/or towing prohibitions must be made known to the RAA in writing when the vehicle(s) is/are picked up and/or delivered to the RAA;
6. **In order to operate the vehicle(s) and demonstrate it's capabilities any special operability conditions, processes and methods that will insure proper operation and movement of the vehicle(s) without damage or incident, including but not limited to battery charging and "jump starting," fuel requirements, latches, locks, doors, hoods, and other compartments that are known to the consignor(s) must be made known to the RAA in writing when the vehicle(s) is/are picked up and/or delivered to the RAA:**

In order to recondition the vehicle(s) and prepare it/them for showing and sale any special reconditioning instructions, recommendations and prohibitions regarding the cleaning, washing, waxing of the vehicle(s) exterior, interior, engine compartment and engine must be made known to the RAA in writing when the vehicle(s) is/are picked up and/or delivered to the RAA:

The interior and exterior condition of the vehicle(s), including its/their operability and any and all restoration work is the responsibility of the seller and the seller will maintain appropriate insurance while the vehicle(s) is/are in RAA possession and until such time as it/they are sold, paid for and title is/are transferred to the buyer(s).
